The European Union is moving towards enlargement. With the possibility of six Western Balkan and three Eastern European countries joining the EU, the bloc may grow by up to seventy million people. As with previous rounds of enlargement, like in 2004, this pushes the EU to prepare institutionally, financially and politically. The conviction prevails that enlargement is a geopolitical necessity. At the same time, it is a lengthy procedure without a quick-fix solution. The aim of this conversation is to investigate the benefits for the EU economically and in its global role and to discuss steps that need be undertaken to make enlargement a reality, including new approaches to the EU integration process.
